

## GEOMETRY OF AWAKENING RETREAT

### Participant Terms & Policies

We are honored that you are considering joining us for the Geometry of Awakening Retreat. To ensure clarity and a smooth experience for everyone, please review the following policies before reserving your space.

### RESERVATION & DEPOSIT

A non-refundable deposit of \$750 is required to reserve your space for the retreat. Your space is confirmed once the deposit has been received.

Spaces are limited and are reserved on a first-come, first-served basis.

Registration is finalized once both of the following have been completed:

- Payment of the \$750 deposit
- Submission of a signed Liability Waiver

The remaining balance must be paid according to the payment schedule provided at registration.

### CANCELLATION POLICY

Because retreat planning involves advance financial commitments, the following cancellation policy applies.

The \$750 deposit is non-refundable.

If you cancel your reservation:

- More than 90 days before the retreat: the deposit remains non-refundable, but any additional payments may be transferred to another participant or applied as a credit toward a future retreat hosted by the organizers within 12 months.
- 60–89 days before the retreat: the deposit remains non-refundable. Up to 50% of additional payments may be transferred to another participant or applied as a credit toward a future retreat within 12 months.
- Less than 60 days before the retreat: all payments are non-refundable and non-transferable.

If you are unable to attend, you may transfer your reservation to another participant with written approval from the retreat organizers.

### RETREAT CHANGES OR CANCELLATION

In the unlikely event that the retreat must be cancelled by the retreat organizers, all payments received will be fully refunded.

Please note that the retreat organizers are not responsible for additional expenses incurred by participants, including airfare, travel costs, or other personal expenses.

Minor adjustments to the retreat schedule, programming, or facilitators may occur if necessary.

### TRAVEL ARRANGEMENTS

Participants are responsible for arranging their own travel to and from the retreat location unless otherwise noted.

We strongly recommend purchasing travel insurance to protect against unexpected cancellations, travel delays, illness, or other unforeseen circumstances.

### HEALTH & PERSONAL RESPONSIBILITY

Your well-being is important to us. Participants are responsible for ensuring they are physically and mentally able to participate in retreat activities.

Please inform the retreat organizers of any injuries, medical conditions, or circumstances that may affect your participation.

Participation in activities such as yoga, meditation, workshops, excursions, and other offerings is voluntary.
